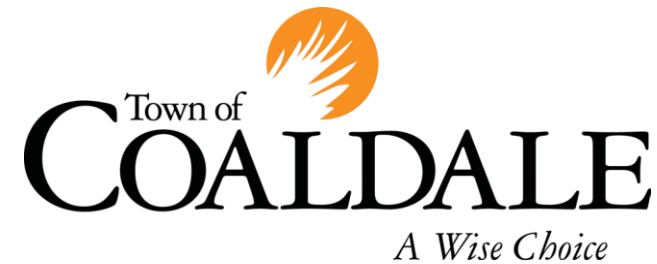

Emergency Advisory Committee (3 Citizen Members)	As required, at least three times a year. 3 - Three-year terms	Responsible for the development, operation and continual enhancement of the town's emergency management program.
Library Board (4 Citizen Members)	9 Monthly meetings, Tuesdays at 7:15pm. 4 – Three-year terms	To act as trustee for the community and assist in Library governance.
Municipal Planning Commission (2 Citizen Members)	2nd Wednesday of every month at 5 p.m. 2 - One-year terms	Review development and subdivision applications and consider approval that's consistent with the Land Use Bylaw and the Municipal Government Act.
Subdivision & Development Appeal Board (2 Citizen Members)	As Required. 2 - Three-year terms	The board hears appeals regarding decisions made by the Development Authority, Subdivision Authority or the Municipal Planning Commission on development or subdivision applications.
