

TOWN OF COALDALE EASTER EVENT COLOURING CONTEST RULES

Town of Coaldale is offering this colouring contest, “the contest”, and is referred to as the “Contest Organizers”. By participating in this contest, the person or child’s legal parent/guardian is agreeing to the Contest Rules and Terms and Conditions as outlined below.

1. CONTEST DATES

- a) The contest begins March 4, 2026 and closes at 3:30 p.m. Mountain Standard Time on April 4, 2026.

2. ELIGIBILITY

- a) The contest is open to all ages. One (1) entry per person.

3. HOW TO ENTER

- a) Pick up a colouring page from the Town Office (1801 20th Ave #200) during regular business hours (Monday to Friday, 8:30 a.m. – 4:30 p.m.) by April 2, 2026 OR download a colouring page from the Contest Organizer’s website: www.coaldale.ca/easterevent2026 and print the page (front and back).
- b) Fill out the information on the back page.
- c) Colour the front of the page however you’d like.
- d) *EITHER* scan (in color) both the front AND back pages and email them to the Town of Coaldale’s Special Events Coordinator, mark.mcintosh@coaldale.ca, OR drop off your entry at the Coaldale Town Office (1801 20th Ave #200) during regular business hours by April 2, 2026, Attn: Mark McIntosh, OR bring your entry to the Town of Coaldale’s Easter Event on Saturday, April 4 between 1 p.m. and 3:30 p.m. in Civic Square Atrium (1801 20th Ave).
- e) By entering the contest, you agree to let the Contest Organizers post your artwork with your first and last name on their Social Media accounts and website, and you accept the terms and conditions of the contest.

4. JUDGING

- a) Entries will be judged at contest end.
- b) Decisions are at the discretion of the Contest Organizers and are subject to change at any time. We reserve the right to award multiple winners and prizes, or no winners and prizes.

5. *WINNERS & PRIZES*

- a) Winners will be notified by email, or phone.
- b) Prizes are as follows:
 - i. 1 first place prize to be awarded to the winner of each age category: ages 1-10, ages 11-17, ages 18+
 - ii. First place: 1 custom t-shirt featuring your winning submission per the Contest Organizers' discretion.
- c) Contest ends April 4, 2026 at 3:30 p.m. Mountain Standard Time, or as otherwise posted on the Contest Organizer's website.

6. *GENERAL TERMS & CONDITIONS*

- a) By entering the Contest, all entrants agree to be bound by the rules of the contest and release the Contest Organizers and all parties associated with this Contest from any liability with respect to the contest and the redemption of any Prize.
- b) Contest Organizers reserve the right to withhold the Prize or disqualify any Contestant's entry in the event that any Contestant fail or refuse to comply with these contest rules.
- c) By entering this contest, Contestants and their legal parent(s) or guardian(s) consent to the Contest Organizers publishing or announcing any Prize winners' name and photograph(s), in future publicity, without permission or compensation to the Contestant or any other party. This shall include unlimited reproduction, publication, use and distribution in all forms and media, and in all manners including advertising, trade, display, editorial, art, video production, exhibitions and website content.
