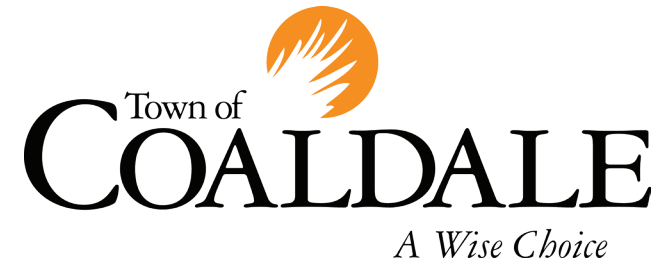

Committee/Board	Meeting Information	Function
Emergency Advisory Committee (3 Citizen Members)	As required, at least four times a year.	Responsible for the development, operation and continual enhancement of the town's emergency management program.
Municipal Planning Commission (2 Citizen Members)	2nd Wednesday of every Month at 5 p.m.	Review development and subdivision applications and consider approval that's consistent with the Land Use Bylaw and Municipal Government Act.
Library Board (6 Citizen Members)	3rd Tuesday of the Month at 7 p.m.	To act as trustee for the community and assist in Library governance.
SouthGrow (1 Citizen Member)	As Required.	A regional, multi-community, economic development initiative.
Subdivision & Development Appeal Board (2 Citizen Members)	As Required.	The board hears appeals regarding decisions made by the Development Authority, Subdivision Authority or the Municipal Planning Commission on development or subdivision applications. The Town of Coaldale is entered into municipal agreements with the towns of Picture Butte, Nobleford & Coalhurst, and the Village of Barons.
