ITEM 172 7.2 ANNEXATION REZONING SUMMARY – S. CROIL

- Councillor Chapman inquired if the comparison of rural urban fringe and urban reserve, are they two distinctive separate components? S. Croil responded that yes, the County zoning rural urban fringe is a zoning that encompasses the majority of the annexed land. The urban reserves is the town zoning we would want to place on those annexed lands.
- S. Croil noted that any of the uses that landowners have requested to be included in an urban reserve district, are approved by Council to be in that district and that opens up the number of possible uses that an annexed landowner can undertake on their property without having an impact to taxation purposes.

- Councillor Hohm inquired if there are any statistics on outages for above ground vs underground? T. May responded that, no, not to his knowledge.
- ➤ Councillor Simpson inquired if the 2nd quote, regarding 21A Avenue to 23rd Street, is there any overhead power lines in that area? T. May responded that no, there is not, it actually comes through the alley. Councillor Simpson further inquired if in the future we decide to bury the lines, could this be easily done with Fortis or would it be a big expense? T. May responded that yes, it would be a big expense. There are a lot of trees in that area.
